Dave Bickers by Sidge Kenny

Dave Bickers had given me so many great moments over the years. It is hard to believe that the great man has gone forever. He represented so much in our sport and our area..The vigour and precision of his riding brought prizes galore – yet essentially he was a man of sleepy old Suffolk, who went on to attain international eminence – yet never strayed from his roots

Dave's successes in the sport which changed from the rurally based: "scrambles" to the more staged: "motocross" are legion. He rose from being



the darling of the Suffolk crowds in the early 1950's to an international star within a decade. Perhaps his greatest time was when mounted on the Essex-made, Greeves machines and thereby we of the Eastern Centre should be doubly proud. But lightweights were not his only rides – big Matchless, Vintage Rudge and sidecars were winners with Bickers at the helm. CZ and Husqvarna kept him competitive at the top levels after the split from Greeves and on a personal note, I recall his epic ride in a Welsh Two-Day Trial (now Enduro) of the 1980's when he rode a Suzuki the best part of a long, rough stretch from check-point to check-point on just the rim of the rear wheel when the rear tyre shredded! You certainly came to think that only Dave would have contemplated such a thing.

The first ATV I ever saw, was a Honda three-wheeler with fat, pimply tyres, which Dave brought back from a trip to the USA – by now he was involved in his very successful stunt work in films and the engineering of special effects. These brought more credit to his name and it seemed the wackier the stunt the more Dave would conjure some way to make it work.

There remains two of those personal memories of my own. First, his truly awesome leap into the "bombhole" at Shrubland Park to lead and win the UK ,"Coup d'Europe" round of 1961 — which brought an ecstatic roar of pride and encouragement from all those who clung onto the steep sides of the bowl — and earlier, in 1958, at his beating of Brian Stonebridge at Falstaff Manor. Both Greeves mounted, both of vastly different styles. Stonebridge, the master, relaxed and draped over the bike like a sack of potatoes , Dave the junior, all-action — upright over the bars and riding like a dervish. "Look at Stonebridge — " , someone in the crowd yelled, " — he's laughing..."! And for many years after then, so did Dave, as his star lit up our sport wherever he rode.

The Recollection Section

Where would we be - as riders - without our observers and marshals? The obvious reply is: "no where and no go" Similarly, where would we be without the other backstage workers such as secretaries, clerks and stewards, and all the other

officials which in reality provide us with our fun on two wheels?

The recent loss to motocross and the Halstead club in particular, of Mrs Avery highlights the great dependence we have on these stalwarts. It is an obvious fact in any sport - including ours - that it is the performances, action, successes or disasters surrounding the participants which attract the headlines and whilst this is understandable without the enthusiasm and generosity of labour and time - and sometimes, money, from helpers and supporters, there would be a complete void. I must declare an interest here because I find in recent years that I have either observed or officiated at more meetings during a season, than I have ridden. Mind you, after fifty-five years of riding you might well say:- " about bl—dy time .." Let's just say, I'm pleased to be able to do a little bit in return and guess this aspect might increase as I get older. Additionally, there is often discussion as to whether this essentially young person's sport should have so many of the grey-haired sector at the upper-end of its administration and this situation is sometimes criticised. Yet the stark fact is that it has been this way for many years - under a democratic system - and simply because someone is getting older does not necessarily reduce their enthusiasm or their ability to do a particular job. I have remarked in the past that among the delegates at the Centre Board meetings, very few are under fifty years of age and fewer still under forty! Yet the sport is very capably managed and the prime factor these "elders" do provide, is experience. Indeed, I go further,I simply cannot understand the ACU's ruling on officials having to stand down when they reach 70 years of age.

Another aspect of the organisation of meetings, and one which is hardly ever raised, is the function of commentators primarily at speed events. We have had some excellent performers on the microphone over the years - I recall the chunky nd ebullient: George, of "GRS" (surely using ex-army, "Tannoy" equipment?) in the 1950's and later on , Slim Barker, with the indomitable Lofty Lucas coming to the fore over the more recent years. These performers for performers they are keep the spectators informed and entertained, throughout a whole meeting's duration - no mean feat in both stamina and background information. Nowadays, I have no hesitation in stating how impressed I am with Charlie Ralph for both his knowledge and clarity. Mind you, Charlie is no stranger to public, "front-ofstage" performing, as he plays banjo in a jazz band. It would be a wonderful moment if he ever had to resort to his instrument during an unexpected lull in the proceedings on the track...
