The Recollection Section

Sidge Kenny

I'll make no bones about it – I do not subscribe to the "football culture" – which has seemingly permeated into our national life well in excess of its real importance. A valid enough sport without doubt, yet as ever, some people take their supposed



enthusiasms too far. For instance, I was sorry to hear of the degree of abuse referees have had to endure – in youth football, mainly from lineside parents. In my book, this is an indication of a lack of respect for authority which nowadays occurs right through our society and in my earlier days was virtually unheard of.

Every sport must have its rules and each sport must have its rule enforcers. Ultimately discipline has to prevail in order to provide that essential element: "fair play" All competitors need to be assured of equal conditions under which to perform. In our own calling there are very full regulations not only controlling how the sport is run but also relating to the potential hazards of motorised competition with which, our delegated officials also have to cover. The fact we as a Cente run so many meetings with comparitively few problems, is surely a testament to the organisation and its rules, which mainly emerge from our Governing body, yet evolve seemingly in a democratic climate and with largely sensible outcomes. Supporters of our sport do not as a rule cause any trouble whatsoever, at or after, meetings and I like to think, go home quietly to a good supper. I can just recall hearing of bad behaviour by European fans at some International motocross races in the 1950's/60's when they would throw stones or in other ways, try to put off riders (often British) who were threatening to overtake their own national heros. We do not hear of such things today – no doubt due to improved fencing .

In all my time in the sport – I only had one occasion to resort to the organising officials in the form of a protest over the way the rules had been applied. It was a Stowmarket trial in the early 1960's and I had been – I thought - unfairly docked a "five" for poising motionless on my Tiger Cub, in a section

"Five – you stopped" Called out the no-nonsense observer.

" - But my feet were on the footrests – I was in control" I protested

"Doesn't matter - the rules state: 'Stopping' - lack of forward motion - five!"

He would not be shifted. Distraught, and later having received the results which confirmed the five, I sent off my letter of protest with a postal order for 10/- (50p) – as was the rule.

It was I think, Ian Lummas, who conveyed the verdict on my protest at a subsequent trial a week or so later.

"We got your protest letter Sidge, thank you."

"Yes?"

"Well - we all had a good laugh at what you'd written..."

"Oh?"

"But really, the observer was right - by the rules.."

"Oh..." My heart hit my boots.

"But we enjoyed your letter so much - here...." And reaching into his pocket, he gave me my rather creased postal order back....

### 2104 Reserved Motocross Number Scheme

The reserved number scheme was a great success last year, enabling the Centre to make a donation of £1,500 to the Essex Air Ambulance, while preventing the need for riders to change numbers from event to event. Unfortunately a few riders still prefer to keep requesting the same number from race secretaries without reserving it. Not only does this reduce the amount we are able to donate to charity, but is very unfair on the riders who DO pay for their number. For the 2014 season it is far more likely that your chosen number will not be available to you unless you have reserved it!

Numbers purchased for the 2013 season will be held for renewal until 31st Jan 2014. Any number not renewed by this date will be made available to all riders. If you want to ensure that you keep the same number for the 2014 season, you must renew by 31st Jan 2014 at the latest. NO NUMBERS WILL BE HELD AFTER THIS DATE.

Any numbers not renewed by 31st January will be made available on a first come, first served basis. If you have not renewed your number by this date there is every possibility that you could lose it to another rider. There are now over 900 riders on our database, any of whom could be entering the same event as you, so it is more important than ever to reserve your number if you wish to avoid having to change it from meeting to meeting. If another rider has reserved the number he/she WILL be given it if you both enter the same meeting.

You can renew (or reserve a new) number by using the postal form on the opposite page. If you prefer, you can also do this online at www.easternacu.org. The cost of reserving your number stays at £5 per season. If reserving the number online an extra 39p is added to cover the fees we are charged by PayPal. This ensures that the chosen charity we donate to does not lose out, and is still cheaper than sending the application form by post.

Riders who finished in the top 10 of the 2013 expert championship have the right to use numbers 1-10, but this is not obligatory, and they may reserve a different number to prevent losing it (wether they ride with it in 2014 or not).

Numbers from 11 to 50 are for experts only.


