The Recollection Section

Sidge Kenny

I have to admit to being baffled as to why the ACU excitedly put out a press release in the wake of Prime Minister, Cameron's announcement in July, on the prospect of enabling motor racing to take place on the



Highways and in cities. It was almost pitiful to read such evident gratitude, which, in my view, is completely misplaced. Mr Cameron made his proposal when visiting the Williams Formula 1 race headquarters and fittingly gave tribute to the earning capacity for the nation which big time motor racing provides. He was backed up in his thoughts on removing restrictions on closing roadways for motor racing by London Mayor, Boris Johnson, who has made no secret of wishing to see a big time motor race – who knows? - perhaps even a round of the World Championship ,held in London. I'm not a betting man but I'll wager my salary as a male model that neither of them had any thought for motorcycling.

I'll go a step further and simply put the difficulties and expense which would be required to put on a "proper" road race in the UK in this day and road closure; the complaints on the inconvenience plus inevitably those on noise; all of which can only be overcome by one essential element – big money. The kind of which is only forthcoming via the backing and resources of the car sector.

The British government has for over a century been tardy over permitting closure of the highway for racing. – and this at a time when foreign nations were far less reluctant to do so. There were a variety of reasons. Over a century ago, motor vehicles were treated with great suspicion in this country. Horse owners - of which there were many - and the railway interests, saw no reason to fill our quiet highways with noisy smelly automobiles (and in today's traffic conditions who could blame them!) We all recall the legal strictures of: "The Man with the Red Flag"- who had to precede each car or "light locomotive", until 1895.

Another factor in not promoting road closure for racing was the accident rate of the very early motor races on the continent, such as the "Gordon Bennet" series and the infamous "Paris to Madrid " race of 1903, which exacted a terrible toll of fatalities including spectators. So many accidents ensued at various points, that the event was curtailed at Bordeaux. These events primarily for cars, catered for motorcycles as well. Indeed 54 came to the startline for this Paris/Madrid race.

Therefore it is hardly surprising when admittedly a little late in the day, in 1907, British motoring interests looked across the water to the Isle of Man to provide a genuine "road race" event. The famous Brooklands circuit which was specifically designed and constructed to improve British motor vehicles by testing and through competition, was opened the same year and from then on, mainland racing has been largely confined to circuits and tracks with all the required facilities and safety factors evolving to the present times. And to me, they seem the most appropriate places where our sport should largely remain.

However, to my understanding there are at least two locations outside of the current; "no racing on the Highway" rule. Wallasey in Cheshire used to have race meetings around the promenade – which I know by personal contact, is a public highway – and I think the other may be Olivers Mount at Scarborough. I can only surmise in both cases, a Local By-law to permit racing, would have been granted by Act of Parliament many years ago.
