The Recollection Section

Sidge Kenny

The two recent tragic motocross fatalities – one whilst racing, the other at a practice track, does put firmly into all our minds the dangers of our sport. That is not to say most things in life do not carry some sort of hazard. I understand the majority of all



accidents occur in the comfort of our own homes – but it would be foolish not to accept riding a motorbike can bring risks and no matter how tight the rules – or how effective the safety precautions, when they are ridden fast or in combat accidents can occur. The odd thing about both Tom's and Mark's fatal occurrences is evidently neither riders crashed after involvement with anyone else. This can of course happen – the rider simply makes an error of speed or line - or his balance goes wrong – or the bike can react in a different way to his expectations – literally jumping out of his hands. It happens to all of us – and we fall off - some of us many, many, times. Most often we get straight up, laugh or swear - and duly proceed. Sometimes we do get hurt – have a period of recovery and perhaps with some caution, get back on the bike again. No doubt Tom and Mark fell off many such times – perhaps at greater speed and in more complicated a manner than in their final, fatal, tumbles. Had they have been able to get up from that one – would they have refused ever to mount a motocross bike again? I doubt it.

In my early days, as you would expect, I fell off many times and this included several crashes on the road . I shudder now to think what the results of such incidents would be with the massively increased number of vehicles now on the highways. Riding to work in snowy or frosty conditions produced the greater number of tumbles which resulted either in grazed skin or in one case, a completely saturated back where the snow had scooped up into my collar as I slid down the road - and very little sympathy when I arrived late for work. On another occasion which still brings a chill to my soul, I virtually wrote off a perfectly good Norton Dominator when - I admit it - was showing off by blasting past a Lambretta scooter. What was worse, was that the scooter rider very kindly stopped and full of concern, picked me up. One of the queerest accidents I had, took place when I was riding pillion to the famous Jim Patey. Riding in the dark, we approached a corner at Jim's accustomed cosmic pace and i knew very well we would not make it. Down we went - and in the silence of the night, staggered around enquiring of each other if we were all right. Luckily we were and then we attempted to find the bike! After feverish searching, we discovered it wedged into the hedge on its side, fully four feet from the ground. Of such incidents are the experiences and attitudes of a motorcycle rider forged.

I think most of us consider we are safer in organised sport than risking the hazards of today's congested roads. The statistics show that to be true. It is in those terribly sad but thankfully rare times in which Tom and Mark were involved which highlights that our safety can never be fully guaranteed in any human activity

Tear Offs

After the announcement earlier in the year regarding the ban of Tear Off's from the 1st January 2016 the ACU Motocross Committee would like to remind all riders and clubs. The ban has been imposed following a number of environmental concerns in recent years due to the increased use of Tear Off's at Off-Road events which has led to the ACU being asked to reconsider the use of Tear Off's across all Off Road Sporting events in the future.



With the increased restrictions to Land Access for Motorcycle events the Motocross Committee who are ever conscious of Environmental issues announce their decision to prohibit the use of "tear off's" in all ACU Motocross events from January 1st 2016. This will be a stipulation in the relevant Standing Regulations as printed in the 2016 Handbook

With many events taking place on private and countryside locations, it has long been an issue with farmers and land owners who use the land for multiple purposes and for this reason the ruling will be as follows:

"Tear Off" lenses on goggles are prohibited. A system where the transparent plastic lenses are retained within the device and are not discarded is allowed."

The reserved number scheme has evolved over the past 4 years; last year was the first when it was compulsory to purchase a number before an entry could be made to any motocross event in the Eastern Centre. This scheme enabled the Centre, on behalf of riders to make a donations totalling £3,500 to the Essex & East Anglian Air Ambulances.

Now is the time to renew your number for 2016. If you want to ensure you keep the same number for the 2016 season, you must renew after 1st December and by 31st January 2016 at the latest. NO NUMBERS WILL BE HELD AFTER THIS DATE.

Any numbers not renewed by 31st January will be made available on a first come, first served basis. If you have not renewed your number by this date there is every possibility that you could lose it to another rider. There were in the region of 700 numbers sold for 2015 so if you don't want to lose your number, renew it NOW.

You can renew your number online at www.easternacu.org or if you prefer by using the postal form on the opposite page. The cost of reserving your number remains at £5 per season. If reserving the number online an extra 39p is added to cover the fees we are charged by PayPal. This ensures that the chosen charities (in 2016 they are East Anglian Air Ambulance, Essex Air Ambulance & ACU Benevolent Fund) do not lose out, and is still cheaper than sending the application form by post.

Numbers 1 – 50 are kept for experts only. Number 1 will be offered to the Centre Champion; in the event that the champion declines, number 1 will not be issued.

Nice to see a Two Man Enduro at Wakes Colne once again. The Halstead Club organised the last round of the Dave Barkshire Motorcycles Two Man and it was a very good event with twists and turn on and off the Moto Cross track also it reminded me of Tye Farm Great Cornard where you can see plenty of action over a long distance, good for filming. In the Championship Class Jamie & Stevie Roper were 1st, Craig Roper with Rob Blackman 2nd while in the Expert Class Alex Walton/Jamie Lagden were 5th, Phil Roper/Paul Belton 8th, Alex Rampton/Nathan Greenaway 10th Graham Mayes & Nigel Ross 11th, Jack Nicolaou with partner Tom Sargent 12th and man of the day Jeff Sharp who suffered two heart attacks last March and it took the medics 29 minutes to revive him finished 13th riding with his usual partner Tim Ford. The Clubman Class we had Matt Smith/Marc Norton 3rd, Phil Whiting/Perry Miller 4th, Les Rampton/Martin Greenaway 6th and Adam Kempster/Keith Potter 8th. There were some sub Classes Phil/Paul won the Experts Vets with Graham/Nigel 2nd and Jeff/Tim 3rd. In the Clubman Vets Les/Martin were 1st, Martin Gunton/Gavin Potter 2nd and Philip & Peter Barltrop 5th. John Austin was the only competitor in the Iron man Class and he was soaking up the applause from the crowd. Two week before the March Endurothon we laid out a short course and tested the system out and then used it at the Endurothon and is was a hit. Next up were the Championship events, first the Hare & Hounds no problem, then Time Card Enduro, the transponders took care of recording the riders times although the special test was timed in our usual way although the timing beam is now ready while at the Two Man the transponders took care of recording the laps of each team member and the special test. It was a doddle at the Four Man Enduro as we had used other transponders before. We hope to walk with system in 2016 and perhaps run with it in 2017.


