

The Recollection Section

Sidge Kenny

I started racing on the grass in the late 1950's – a time where the activity was accompanied by the aroma and aura of Castrol"R", in which the pungent smell added a great deal to the overall excitement and quite literally, the atmosphere. As its name implies, the



lubricant was of plant extraction from Castor oil, which in earlier times was also used - in somewhat different form - as a medicine. Castor oil and therefore "Castrol R" was considered a better lubricant than the mineral oils available in the early days of internal combustion engine development . During the First World War, the rapidly evolving aircraft engines and in particular the "Gnome" rotary type (which really did rotate!) placed a high requirement for a good lubricant and thus castor based oils were used by the Royal Flying Corps. The early fighter pilots often recalled the singular smell as well as the nuisance of the drips and leak sprays which covered their flying-suits and goggles

So castor oil came into motorcycle sport and stayed in it for many a decade – and occasionally at a meeting nowadays, you will still get a "whiff". As one of the many 1960's Villiers two-stroke users, I certainly raced on "R", though I actually used a BP version. I have to admit, I was never totally convinced of the lubricant's claimed effectiveness. With a two-stroke, it did not mix easily with the petrol and when you stripped your engine at the end of the season, there was always a gummy varnish deposit – surprisingly hard - to clean off from the internals of the engine. Later in my racing period, I resorted to standard mineral oils – with no ill-effects.

However, I was to be proved wrong after an incident at my work. I had taken in an outboard motor which had suffered a partial seizure when its water-pump failed. After repairing the pump and despite my recommendation to strip the power unit and investigate the tightness, the customer, - a rather dour-looking Northerner, was very concerned to get away on the earliest tide and urged me to get the motor running – any way and any how. The engine duly popped and strived to run but the internal friction was just too much. It was like a man with a gammy leg escaping from a fire – keen, but ineffective. I tried pulling the recoil starter all the harder without success. In sheer desperation, I drained all the fuel and refilled the tank with a mixture containing a very high proportion of what was left of my castor racing oil.

Both to my - and my client's - surprise and delight, after a few pulls, the motor duly fired up and ran for a protracted test period. Smoke was everywhere and as it ran, the engine audibly freed off and settled down My client was clearly very relieved and for the first time in our contact, grinned broadly. I thought he was about to profusely thank me for my great efforts on his behalf.

"Eee - but that's a grand smell" he chuckled...
