The Recollection Section

Sidge Kenny

I have said it before - in my opinion the most under publicised and under recognised area of all motorsport - yet the one which can be the most thrilling and entertaining, is that involving sidecars. In every discipline they compete in, the chairs



make for compelling viewing and I am sorry that they do not feature on Moto G P and by the same token I am pleased to see they are a very important feature of the T.T.races – where, on that course, it is the supreme test of machine speed and reliability and rider (and passenger) judgement and courage. But what ever, the chairs when included in a trial are good value – are impressively fast in modern motocross; run both ways in tremendous combat on the grass – and on the speedway shale. What is it about these combos which makes them so intriguing?

My theory is that if anyone was to be asked today to design a three wheeled vehicle entirely from scratch, they would never design a sidecar. From their drawing board they would produce surely, a "two-wheels at the front" lay-out, such as on the early Morgans or Owen Greenwood's highly successful, yet widely detested, mini powered trike which certainly livened up sidecar road races in the 1960's – or alternatively the "one wheel at the front" type, as per the early ATV's of Honda - and yet this design was virtually banned after accidents due, surprisingly, to their instability at speed on the rough.

It is evident, also that the sidecar itself was essentially an afterthought – the need in the early days to improve the carrying capacity of a motor "bicycle". Up to just a few decades ago, some riders would indeed join a sidecar to their solo for use during the winter months and almost as long motorcycles have been ridden, the dear old motorbike and sidecar plodded many a family around the country, enjoying as a result, lower insurance rates than practically any other vehicle.

The other element which makes sidecar sport unique, is the fact that two people work onboard as a team and the better they unify, the more successful the outfit performs – from trials section to race track. This also makes chair activity seemingly more sociable than the solos and as an example I recall many years ago witnessing at a trial in an Essex wood – it might have been Warley - where during the event, all the chairs stopped, gathered round and made an impromptu presentation to one of their number: George Wolfe, a US serviceman who was a regular trials competitor and was soon to be going home to the USA. I have never seen a similar – rather touching – little ceremony anywhere else in the sport and I doubt I will.

With all this enthusiasm, have I ever been tempted to get aboard a chariot? Yes indeed but I was woefully incompetent as a passenger and in effect, was given a red-card with accompanying robust reprimands by my pilot: Sergeant Roy Hall. This again was at a

trial in the 1960's, at Friday Woods, Colchester, aboard his Royal Enfield and chair. My memory brings back myriad crashes, tip-overs, violent contact with trees and fairly constant blasphemy from my "gruppenfuhrer" It seems I was unable to follow simple

instructions or in Roy's case, orders and had I been in khaki, I would have certainly been placed on a charge. I think we retired due to "clutch slip" – but we both knew the proper reason. There fore, as in so much in life, I admire the chairs and their valiant handlers from a safe distance and very much with the same awe in which I regard bungy-jumping or crocodile wrestling.



Tear Offs

After the announcement earlier in the year regarding the ban of Tear Off's from the 1st January 2016 the ACU Motocross Committee would like to remind all riders and clubs. The ban has been imposed following a number of environmental concerns in recent years due to the increased use of Tear Off's at Off-Road events which has led to the ACU being asked to reconsider the use of Tear Off's across all Off Road Sporting events in the future.



With the increased restrictions to Land Access for Motorcycle events the Motocross Committee who are ever conscious of Environmental issues announce their decision to prohibit the use of "tear off's" in all ACU Motocross events from January 1st 2016. This will be a stipulation in the relevant Standing Regulations as printed in the 2016 Handbook.

With many events taking place on private and countryside locations, it has long been an issue with farmers and land owners who use the land for multiple purposes and for this reason the ruling will be as follows:

"Tear Off" lenses on goggles are prohibited. A system where the transparent plastic lenses are retained within the device and are not discarded is allowed."


