The Motocross forum will be held at Walsham-Le-Willows football club on Friday 16th September at 7.30pm; and the Trials forum will be on Thursday November 3rd at Gt Blakenham Parish rooms.



attraction for motorcycles, since there are warning signs along the route specifically highlighting accident black spots for bikes. I had thought Mark has had the perfect partnership with "Bertha" - his trusty BMW - which after a considerable heavily laden mileage, had seemingly been totally reliable. However he had within a 20,000 mile service, needed new steering head and rear wheel bearings, plus a new handlebar, "on-off" switch and a set of tyres. He reports he does get around 7,000 miles from a set of tyres, which bearing in mind the weight the bike carries and the wide variation in road surfaces, cannot be at all bad. However he did suffer one emergency when he had to repair a front wheel puncture alongside a busy freeway! When you think of the hazards on the A12 here at home, that must have been a daunting experience.

Now into New South Wales, he has crossed the Great Dividing Range which was another memorable experience, including taking in the view of the Wallomombi falls. It has not always been comfortable riding however, lashing rain and contrary perhaps to our conception of the Australian climate, very chilly temperatures, have at times tested his endurance.

By early August he had once more reached the main coastal road and had arrived at Kempsey the birthplace of Australian folk singer: Slim Dusty – who, old timers like me will recall his 1950's hit song of: "A pub with no beer" - though I hope this was not the case when Mark rode into town.. The Regs are in this month's Gazette for our round of the Dave Barkshire Motorcycles Two Man Enduro on 18th September so please get your entries in now. The venue I can now reveal and it is Tye Farm Great Cornard our Spiritual home, we have permission to use it for this year however we can only access the course area on Saturday and Sunday so it is going to be a tight schedule.

Anything Lewis Hamilton can due in the month of July Stephen Green can do just as well I wrote in a media report. Stephen has gone back to Grass Track racing and in July won THREE Titles being 2016 British 500cc Upright Grass Track Championship then onto the South Eastern Centre Title and thirdly the ACU Eastern Title at Iken. I was at Iken to see him win all his four legs and made my first videos of Grass Track, Most of the time I was filming blind as the light gets into the view finder then again my filming is naff but the zoom works very well. I found this also out at the Diss evening Moto Cross I was standing at the end of the starting straight and after zooming in I got the riders going over the container in the second field. Stephen started in Moped Speedway at his local course in Great Cornard went onto BMX, Junior and Adult Grass Track then onto Enduros and now back to Grass Track being our best GT rider since Tom Smith in the late 1950s early 1960s.

We had six members take part in this year's Red Bull Romaniacs being Silver Class Stevie Roper and Jack Berry, Bronze Class Paul Belton and Phil Roper and Iron Class Martin Gunton and Gavin Potter. These six were having a few beers after the Welsh Two Day two years ago and as they got mellow they decided to enter. The Prolog was okay for them but when they started the four day event they found the hills very steep and they had to descend them and a note to Ross Noble 'they are not Yorkshire Hills', this is a reference to the interview I had with him after our 2015 Extreme Enduro. Our riders enjoyed their Romania experience although one by one over the four days they gradually fell by the wayside. However the star of the sextet was Paul Belton who rode the full four days but did not make the finish but was credited with 149th beating Phil Roper who was the first one to retire although he is credited with 171st in the Bronze Class. Meanwhile the Silver Boys Stevie Roper and Jack Berry were 78th and 91st while the Iron Boys Gavin Potter and Martin Gunton were 80th and 82nd.

On one of these facebook sites a Peter Cocksedge who used to ride saw these and as I have given Alan a credit he contacted me and told me he was Alan's cousin who he had not seen for many years so I gave him a contact number and just recently they have met us and found out things they didn't know about each other families. It is nice to know that good things do come from the past.

However, he came back strong on the Sunday to get a win, and 3rd overall at the two day event. Adam Day was again consistent to finish 9th overall, with James Miles 13th on the day. In the junior clubmans class, Jack Gatland and Steve Atkins were 15th and 16th overall.

Sam Mitchell was spectating, and his injured shoulder is starting to heal, and if all goes to plan, he may ride at the Weston Beach race in October. Sad to report that one of our lads, Darren Francis, broke his arm whilst practising recently, we wish him a speedy recovery.

Entries are coming in well for our final MX meeting at Blaxhall on 11th September for the penultimate round of the Eastern champs, fingers crossed for good weather.

Finally, I finish these notes with some very sad news regarding the loss of Simon Jarvis. Simon was a true "grass roots" Eastern Centre motocross rider, who rode over a long period, at lots of venues in the Eastern region.

Those of us close to the sport will miss #75. On behalf of the Woodbridge club, and I am sure, other clubs as well, we send our sincere condolences to his family.



Recollection Section

It is funny how after a long period of being involved in motorcycle sport, when I think back over the years and all those meetings, it is often the little side issues that come to the

forefront of memory. That is to say, I may not be able to recall much of what happened in the actual riding part but some other aspect is very clear. To give an example: if ever I meet up with Beverly Roper – wife of never-to-be-forgotten Dave, and mother of the Roper enduro dynasty, we will invariably make reference to our trip to Scarborough as part of the Sudbury team for a two-day meeting many years ago. Whilst going around the town, I bought in a "50p shop", both an adjustable spanner and a pair of underpants. This caused enough merriment anyway, which was greatly heightened when during the event, the spanner broke in half on first being called upon for use – and I'd rather not reveal what happened to the underpants. Many years have passed since that time but Bev and I still have a little chuckle over it when we occasionally meet up . Yet I simply cannot remember much else about that week-end.

Years before then and with other colleagues, I was returning from a trial - I think at Aveley, organised by the Barking and East Ham club - in my somewhat dilapidated Ford van in the pouring rain, when at Witham, (this is before the bypass was built) what appeared to be a black robot, strode out into our path and held out an arm for us to stop. The creature had a long wand seemingly coming out of its pointed head and I must admit myself and my passengers were somewhat alarmed at this sudden dramatic appearance. As we drew up, we could then see in the murk that it was a policeman in old fashioned cape and helmet, plus a back pack laden with "walkie-talkie" radio equipment. The "wand" proved to be a long, wispy aerial. I wound the window down and he thrust a hand in and waggled my steering wheel. "Checking your vehicle for road worthiness – is it taxed?" he squawked in a voice that reminded me of Bluebottle from the Goon Show. I pointed to the licence disc. The poor chap was so encumbered by the heavy radio gear which seemed to be chattering audibly at him all the while, that it was impossible for him to check all the other items which police would inspect in those pre MOT days. So with a wearisome wave of his rain-sodden arm, we were soon dispatched. As we pulled away, we all exploded into laughter. Again, I cannot recall a single section or my performance at that particular trial.

Journeying to Lowestoft, alone to a trial which might have started at Toft Monks or Haddiscoe, somewhere near to Beccles, a little Jack Russell dog came racing out of a field, literally under my wheels. I braked as hard as I could but the poor dog ran screaming off seemingly badly injured. I looked along at the field . A grey T20 Ferguson tractor was pulling a potato planter with two people riding on the rear – their backs to me. I ran up and made myself known. "Have you a Jack Russell" I asked? " - Yea, Boko. " one of the two old boys replied. I explained what had happened and promised to return after the trial. He pointed to a bungalow further up the field. I went on to ride in the trial but was in truth badly affected by the incident. Poor Boko, I imagined him lying and dying in great pain. On my way home I parked my van and walked gloomily up the path to the bungalow. But there at the front window, I heard a barking and yapping and the fleeting sight of a doggie's head bobbing up and down. Boko was clearly in perfect order and very pleased to see me – as I was him. "Teach him a lesson" the old boy said, as his wife made me a cup of tea. Again, don't ask me how I got on in the Lowestoft trial that day - I can't remember - but I'll never forget Boko.


