Mark's Progress

This is to be the last report of Mark Kemp's epic 20 month motorcycle journey around Australia, Tasmania and virtually the whole of the Americas – where he weaved in a west to east, south to north and back again in a double bounce!. By the time this report is published Mark will be home and having to pick up the threads of a normal life.

Along this immensely long ride (70,000 miles) on his faithful 800cc BMW "Bertha", he has endured all kinds of weather, from grilling heat to abject bitter cold - to bone dry and drenching rain. He has ridden all manner of road surfaces from motorways to virtual scramble courses – in all sorts of traffic conditions from grid-lock to sharing the roads with wild life only. And to his everlasting credit, he has never fallen off! He did end up in a Peruvian ditch after being knocked by a taxi, but his helmet-cam



recorded no fault was his. and damage to Bertha was very minor. Along the way, he has been followed – certainly by me, to the great expansion of my own knowledge of world geography, but also by scores - possibly hundreds - of others, either along the route or by the media tool of "Facebook". In those episodes, Mark has been given both greetings, support and sustenance - and at times, welcome contributions to the fund raising effort for Teenage Cancer. I must personally congratulate him for the planning which he obviously put in to the undertaking, for he seemed never at a loss as to:- "where to next?" and always, if asked by me through E-mail:- "How is it all going?" his summaries were informative and to the point.

BMW's have always had a high reputation for reliability and Bertha continued that trait with honours. There were of course, needs to service and repair plus the odd replacement. I could understand tyres, brake pads, oil and filters being necessary but was surprised that steering head and front wheel bearings had to be replaced — even on a journey of this magnitude. The load of equipment the bike was carrying, admittedly did increase the stresses on the frame and once, some re-welding was needed. In many cases the local BMW dealer gave Mark priority to keep him rolling and some even did it for free. At no time did he come to be in danger of being out in the desolation of the desert roads or the artic circle tracks, through a breakdown. His worst moment may have been having to repair a front wheel puncture alongside the busy freeway into Sydney — I imagine it to being similar to a breakdown on the A12 or M25!

No doubt many of us in the Centre will get to talk to Mark over the next weeks and months and discuss his great achievement. Appearances on local TV and Radio are surely to come and he most certainly has enough memories and material to produce a book. Nonetheless, probably the most satisfying response I guess he would wish for, would be some more: "glad to have you home" contributions to Teenage Cancer Trust: a most worthy charity and can be reached on: www.justgiving.com/Mark-Kemp3 Currently he is nudging £Ten grand – lets get him over the line.

Finally, Mark's ride concluded with a run from the deep south of the USA, riding north east up the Blue Ridge Parkway (Highway) to Washington and then up the east side – now virtually coastal to Philadelphia, which city he much enjoyed but going northwards to New York, he did not like the

dense traffic the he did include a visit to the famous `Orange County Choppers` just upstate of the city. The coast did then feature - Two days in Cape Cod, before going into Maine and then west for a visit to Niagara Falls, ostensibly his last major sight seeing – though he hoped he might quickly nip off to Detroit – before Bertha is to be shipped from Toronto. No doubt Mark`s transition home will be quicker by air

His overall thoughts on the great adventure are of roads of all kinds, scenery sometimes stunning but always interesting and people of all colours and creeds, invariably kindly and supportive. It has been a lifetime experience and he has accomplished a teenage dream.



Recollection Section

Sidge Kenny

I first saw James Shanes in action some years ago at a National Under-21's grass track championship meeting held at Ugley.



I am not one to over-utilise modern technology but he was so impressive that I took some video of him doing his stuff. Right away it was evident that here was a young man who could ride a motorbike exceptionally well and moreover, in racecraft, had what it takes to get to the top. Like most of our leading riders today, he had come up with encouragement from his parents and via the worthy "youth route" - yet he undoubtably possessed that "something extra" as he went on to be Under 21 British Champion in 2014 and then win the British Masters Challenge the same year. In 2015 and 2016,he became British Masters champion (500cc) and both 2016 and this year, James has taken the European Grass Track title. Further, for 2017, there has also come a World Longtrack round win which helped to lift him into fourth place overall after the final meeting in September. Add all of that to a speedway career currently with Poole Pirates and add championship wins on the sand and you get some idea of the talent of this young man of just twenty years of age.

I don't think I had been so impressed by a visiting rider since the late Chris Pusey literally burst on to the scene some fifty years ago, when the Castle club ran National Grass Track meetings at Aldham. Pusey was to my recall, somewhat older – though not by much – than James Shanes and again from memory, I think he was already riding in speedway for Belle Vue when he came down from Liverpool to compete in this Centre. I had not heard of him but it was clear from his first practice laps that here was a most spectacular performer, who flung his bike full chat and in speedway-stlyle broadsides on a far from level field at Aldham. "He wont keep that up!" declared Don Godden – who of course, was no slouch himself. But to the delight of a large crowd, Pusey did keep it up in tremendous form and so made his mark on the meeting – definitely "Man of the Match"- that he received a standing ovation as he circulated in a well-deserved lap of honour. at the end of the proceedings. I am a little hazy and stand to be corrected but I think Chris Pusey did not quite reap the full value of his undoubted talent during his career – what the reasons were I cannot say – but after fifty years, I still recall his Eastern Centre debut as one of my all-time motorcycle memories.

I am fairly certain James Shanes will, barring anything unfortunate, prosper both in victories to come and hopefully financially from his brilliant career so far. He has many seasons ahead and I get the feeling there is a good organisation behind him. His machinery from what I saw, is top rate and rapid and at the Ugley meeting, his bike seemed geared to perfection. Grass track racing, even less than moto-cross and trials, does not get the national coverage it deserves and to most, is indeed a "hidden" sport. But with a youthful personnality and star performer such as James Shanes to attract the media - it might just get the break it needs.


