The new season beckons and it's good to see that the motocross regs are once again featuring in the gazette. It's going to be a stellar start to the campaign with Norwich Vikings organising the opening round of the Maxxis ACU British Championship at Lyng in a little over a month's time, closely followed by the first round of the Centre championship at Blaxhall just



a couple of weeks later. The Trials championships start in earnest with both the A and B class in action at Aldeby and Poles Wood on consecutive weekends in February; while the Enduro season kicks off in Thetford Forest at what is always a highly competitive and well supported event

Once again one of the longest serving members of the Centre has passed under the chequered flag for the final time, and I was truly saddened to hear of the death of Ken Davis. You will find an obituary in this issue of the gazette, but one thing it doesn't mention is that Ken only 'retired' from actively attending events and helping with whatever jobs needed doing, at off road meetings right around the UK right up until the age of 80 – a truly remarkable innings!! And more often than not he would still be travelling on a bike......

There are still some tickets available for the Centre Awards function on February 12th at Stowmarket, and with nearly 100 already sold it promises to be another superb gathering where the champions, from youth through to classic, receive their hard won rewards.

And if you fancy another night out amongst friends, don't forget that Mark Kemp will be talking all about his epic world trip on 'Bertha' at the Cedars Hotel Stowmarket on March 2nd. It promises to be an entertaining and fascinating evening as he recounts some of his adventures in Australasia and the Americas – I believe Bertha will be there too!!

Ken Davis by Sidge Kenny

Not many of us get to write their biography - possibly on the grounds of nothing much to write about - but Ken Davis, who passed away in early January, did so and it duly came out in



paperback last spring with an eyecatching photo of Ken on the front cover, showing him riding his trials Bultaco over the roof of a car.

The fact he did write his life story means there is a good personal record of his eighty four years - which, living in East London - had a perilous start with the aerial bombing of the secondworld war. He had early memories of times spent in a bomb shelter with his Mum, Dad, and sisters. As he grew, it was evident Ken was an intelligent lad who did well at school and progressed quickly, with an early talent for music and intellectual subjects. He also disliked sports which did not at first give any hint of his later association with motorcycles. Like most of us however, he enjoyed riding a bicycle and in his later teens, he acquired a Corgi, an ex military, paratroopers folding motorcycle of 98cc,- this from the unlikely source of his Auntie Olive. The little Corgi got him on the road and started a career which covered decades and many thousands of miles.

Ken was of an age where the Military "call-up" was in force and after a medical examination, he went off to do two years service in the RAF. This may well have been one of the happiest times of his life, for his musical talent soon had him placed in the RAF No 5 Regimental band, stationed near Weston-super-mere. Being in this outfit granted Ken privileges over the normal servicemen, as the band performed at many public functions around the country, including the playing in London at the Queen's Coronation of 1953. That same year he traded in the Corgi for a BSA "Bantam", on which he recorded nearly 20,000 miles in just over two years and additionally on this bike, he took part in his first trial, organised by the West Essex club in November 1955. Unfortunately the Bantam was not fully adapted for trials work and Ken had to retire. Nonetheless he had caught the bug and joining the Barking and East Ham club, he continued to ride – subsequently swopping the Bantam for a new Francis-Barnett trials model – a make he stayed with for competition riding over several years and used it to take up scrambling (motocross). Bad luck struck again, for he broke his leg riding the F-B at a meeting at Aveley.

The exceptionally s high mileage of Ken's road riding was to be extended when he bought one of the first Ariel "Leaders" and his rides included regular trips to Scotland for the Six Days trial – as a spectator and also a keen walker. Inevitably he was attracted to the ACU "National Rally" and competed in it on many occasions, winning several awards. All the while, he had progressed to becoming the Barking club's treasurer and then its representative on the Centre Board. In 1977, on the retirement of Bill Swann after over thirty years as Eastern Centre Secretary, Ken took over that position having had some instruction by Bill on the requirements of the job and with

his recommendation to the Board. Ken held the post until 1989, when he resigned – and he had continued to ride in trials during much of that period - now on Montesa and Bultaco machines.

As his riding days came to a close, Ken generously gave his services as either observer or marshall – depending on the event – to any club who could use him, which speaks for itself. Sad to relate, dementia slowly crept on him in later life and with some evident difficulty, he was able to complete his 252 page biography before his passing.

To those who knew him – including myself – Ken was an affable quietly spoken man, who nonetheless had definite views on what was right or wrong and never ceased to stand by them.

With his slight stature and thick glasses, he never really looked the picture of a competition motorcyclist, yet to my mind, the Sport and the Centre - as well as his many friends and colleagues, will remember him with great affection.



Recollection Section

Sidge Kenny

I wonder if I am the only one who felt Ross Noble had something of a bad deal when he rode in last year's Scottish Six Day's Trial. He is of course, much better known as a comedian and in this role




as a showbiz personality, perhaps we should thank those who sent him up there to later feature in three weeks of an unprecedented hour long T. V. coverage of the top trial of the year - the station being the cheerily named "Dave" and was broadcast just before last Christmas.

I like Ross Noble's humour. On stage, he comes over as somewhat rueful, slightly out of focus with the world and much more appealing than the clever-dick almost snarling attitudes of many of today's so-called mirth-makers. His is a softer humour and that was evident in his reports to camera on the day's proceedings in the trial. He knew he was not riding well and was intimidated by the event and some of the people in it. He was determined to finish and that is always - what ever the event - the first priority and I was rooting for him to do so all the way - just ask my wife! Ross is well known as a keen road-going motorcyclist and has also done some competition work, including long distance off-road events. Just how much in modern-style trials riding I am not sure. Yet, judging from what I saw on the box, he was far from ready to take part in this, the ultimate contest in the British trials scene. He showed us his "practice section" at home in Kent – a nice enough short bundle of rocks – which I doubt I would clean in a whole afternoon of trying. Yet even this did not give him adequate preparation of the sheer length of the rock- strewn Scottish sections, where each internal hazard is followed by another and another and another. Emma Bristow gave him the best advice early on, when she said: "Make sure you know where to go" - unhappily it was clear, on section after section, after a few promising yards, Ross lost his compass and hit things off-balance. I think that in such a situation, I would say to Ross: "Bugger the cleans - go for a three, use your legs and try to foot your way out ". It seemed that policy, simply did not occur to him and for that I blame his trainers. Good footing can save many marks.

However, due to his own determination to keep going and some rather late but well merited encouragement from his team mate, Ross did finish the event and he was not last. As I said, he is a comedian, not a regular trials rider - nor even particularly athletic. Over all I felt it was a great achievement.

There have been several show business personalities over the years, who got involved with our sport. Film star, Steve Mcqueen in enduro desert racing; remembered by many for his motorcycle leap in: "The Great Escape" - which he did not actually do.
