Whilst talking to members away from the meeting one comment that I received was that a person did not attend himself because he knew another person who would attend and would tell him what happened; this misses the point and is akin to not voting at a general election because other people will vote; if this was taken to the extreme would you be content if the government was elected by a single person who bothered to vote?

The Centre is a democratic organisation and operates in accordance with decisions made at meetings but those decisions would carry more credibility if all clubs attended the meetings to provide input and cast their votes.

Please consider if you can find some time to support the people who give their time voluntarily to support the sport.

Without support from the clubs the Centre will not survive.

The Group also held a motorcycle Triathlon at Snetterton where the riders rode a trial a scramble and a 1 hour road race.

Recollection Section Sidge Kenny

The great Dave Curtis, one of the few riders in the 1950' and 60's, who could get the very best out of the mighty – and heavy - Matchless scramblers in the days before scrambling gave way to motocross, was once reported as saying: "The best suspension is soft tyres...!" I cannot say if this was a wry poke at the AMC forks and the rear shocks of the day – which admittedly, were much the same as fitted on the road machines – or whether he was serious. Yet over the following decades without doubt it is the vast improvements in suspension which have made the nowadays normal -

yet astonishing - performances of both motocross and enduro bikes over the bumps and very spectacular jumps. From a time when the scramblers mainly raced on undulating farm land – usually muddy - with just a few moderate leaps, we now have developed to the 'technical' circuits providing awesome displays of bikes soaring in the air, higher and for longer than some home-made kites. Both Moto-cross and Enduro as off-road sports have developed greatly as a result of those developments in suspension – particularly at the rear end - and for that, most of the credit must go to the Japanese.

From the mid 1930's when BMW produced the first oil damped telescopic forks – for road racing - the rear end of a motorbike was well 'behind' in getting acceptable springing. Pre-war, most motor bikes had no rear suspension at all. Some major manufacturers such as Norton and Velocette did offer on some of their machines, either a plunger system or early versions of the swinging arm and rear shocks we see today but our industry was on the whole slow to see the need and it was up to a few private enterprises, such as the Macandless brothers to provide kits to convert rigid rear ends in to sprung form. In early post-war trials, Royal Enfield were considered pioneers and much against the opinion of the time, in competing with rear wheel springing. As is usually the case, their resultant success encouraged other firms to convert.

That was fine for the time but the rear end damped rear suspension unit, as it was attached to frame and rear swinging fork, gave only a few inches of movement. Off-road sport, over the years demanded much more movement and preferably: "progressive" - i.e., easy and softish on the little bumps but offering more of a longer and ever-stiffening stroke for the big ones. Various fitting points were at first tried – the telescopics at the front of the bike were less of a problem –



extended movement was much easier to achieve but the use of a conventional rear suspension unit with more movement, ended up with a very tall and for many, a largely unwieldy motorbike.

As ever, it seems the big four Jap firms – having been a little slow in getting on to the 'rough' side of motorcycle sport, saw the problem of needing to improve rear suspension and set about devising major re-designs. To my recollection, it would have been Honda in the very early 1980's who first brought out the answer to the back end problem with their: "Pro-link" - a clever system of leverage connected to the shock unit and swinging arm, which gave soft and rapid response to the little bumps and adequate resilience to the whoppers, allowing the rider full control – (most of the time...). Of course, other versions quickly came out and today, the system of geometry and hydraulics is combined as a matter of course. The Japanese as they would, followed up their technical innovations with brisk marketing and such was the

I count that major emergence in rear suspension as the most significant improvement in motorbike design I have witnessed in my time — though perhaps closely followed by the amazing progress also made in two-stroke engines. However, the Japanese were not entirely responsible for that one — but that is another story — with a somewhat darker side.

overwhelming improvement on the new competition bikes that both Motocross and

Enduro were, in effect, reshaped.



BARRY HOPES FOR ENGLAND'S BEST AT SUDBURY SCRAMBLE

Just in case you miss these two landmarks, you are certain to find a varied assortment of bicycles proppe up round the house, and inside the garden shed you will see yet another motor-cycle. Also in the area of the garden there is an auto-cycle.

The four Chaplin brothers are all, as you will have guessed, keen motorcycling enthusiasts, and more especially 18-year-old Barry Chaplin, who is competition secretary of the Sudbury Motor Cycle Club.

In that capacity he is responsible for most of the organisation of the club's forthcoming scramble at Tye Farm, Great Cornard. on Runda May 28.

When one of our reporters went to the Chaplin household last week we found Barry sitting in the drawing-room surrounded by various trophles (not all won by himself) and typing out a letter to Andy Lee, one of the well-known stars of the motor-cycle scramble world.

Barry, who must be one of the youngest ever organisers of such a big event as the club plan to put on, was calmly confident that everything will go off to plan.

Although this is the first scramble ever to be promoted by the club, it looks like attracting most of England's top riders.

Already entries have been received from Johnny Giles, the Triumph works rider; Geoff King, the Taft brothers, Andy Lee, Freddle Mayes, Peter Smith, Mike Scott, Jack Hubbard, John Ford and Jim Alm.

England's best

If that is not enough. Barry hopes that Dave Curtis, England's best 500 c.c. rider who finished second in the 1959 World Championship, will be taking part, alongside another big star, Gordon Jackson

Due t the heavy amount of work that he will have to do on the day. Barry will not be taking part. He is actually more of a trials specialist, and during the winter he entered for nearly every event in the Eastern Centre.

Also riding with him on many occasions was 19year-old Roger King, of Pot Kiln Road, Great Cornard They had to ride to the events on their trial machines, and often rode about 100 miles, not counting the distance they travelled in the events. Both the boys have now reached expert status, and so far Barry has won six trophles.

Novice class was won by Ralph Petts 17 with Colin Brand 24. Section 11 being Colins downfall dropping 8 marks compared to Ralphs 0.

The intermediate was another close one with Stephen Bland 16 finishing just one mark ahead of Richard Beales

The youth continue to shine with Daniel Adcock red route 34 marks well up with the intermediate adults and Jack Holmes white route 19 marks is just 2 off the adult novice class winner.

Notes from ACU Eastern Trials Forum - Nov 1st 2023

The 2023 Trials Forum on November 1st at Chequers Indian Lounge, Great Blakenham, was attended by 33 riders or organisers representing 12 clubs, the full minutes will be posted on the ACU Eastern website, here are some points of note.

- For 2024 the format of all centre trials championships will remain the same as 2023, except for the three points below,
 - a) Youth. For 2024 the Youth Championship classes within B Class rounds will remain as 2023, that is Youth Expert, Intermediate and Novice. Where a club organising a B Class round can offer a beginner's route (lower than white) there will be a new Youth Beginner class. For 2024, dependant on how many B Class rounds can incorporate the Youth beginner class, additional rounds may be added to ensure there are sufficient rounds for a Championship. Organising clubs that can offer an appropriate venue and route will be considered. This is included for 2024 to gauge interest from riders and clubs. Once proposals have been received the calendar will be reviewed and updated. Points will be calculated but there will not be a trophy in 2024. Once a rider has ridden as Youth Novice or above, they cannot score points as Youth Beginner. All youth classes remain open to all ages of youth rider's dependant on parents or guardians ensuring they are capable of riding the class entered.
 - b) Pre 70. For 2024 it was decided to make a small change to simplify the machine eligibility rules that will not affect any current machines. Also, for 2024, in addition to the normal inspections during trials, before some C Class championship trials, riders will be asked if they believe their machine complies with the current ACU-EC Pre-70 machine eligibility rules. The trials committee is always open to more volunteers to get involved in checking machine eligibility; the only requirement is to have some knowledge of the type of machines being used.
 - c) Air Cooled Mono. For 2024 to identify demand, for no annual trophies, championship points to be calculated for any riders of ACM in A Class rounds riding red/blue and white routes, if appropriate riders will also score championship points as Intermediate A or Intermediate B.
- After discussion it was agreed that consistency of observing may be improved and new
 volunteers may be encouraged if an "Observer's Guidelines" document is prepared and made
 available to all clubs, volunteers agreed to produce a draft document for review by the Trials
 Committee.
- 3. Comments were made about the amount of looping occurring in some trials, after discussion it was agreed clerks of course to be asked to consider how to control this when marking sections, and riders to be instructed to ask the observer before riding the section if there is any doubt and the rider maybe taking a new line through a section.
- 4. After discussion it was agreed for 2024 clubs will be allowed to accept paper entries for championship rounds. These entries can be in addition to online entries and all entries must respect the closing date. To support this a generic trials entry form will be included in the centre gazette.
- Currently some clubs are not publishing on Sport:80 accepted entries before or after the closing date, after discussion it was decided that if clubs are using Sport:80 all accepted Sport;80 entries must be shown after the closing date
- 6. Recognising observers are ageing and therefore will disappear over time, after much discussion there were several suggestions of what clubs could try, the list is detailed in the minutes.
- 7. Trials official seminar is to be arranged based on demand, currently there have only been two applicants identified by clubs. P Nash offered to organise a seminar if date and venue can be agreed, it was agreed that an evening would be preferred. Any interested new applicants to please contact their club.
- 8. Following a successful 2022 Trials Awards Presentation evening, after much discussion including understanding what other disciplines are considering, it was decided whether there is a multi-discipline 2023 centre annual awards presentation event or not, a 2023 Trials Awards Presentation will be planned. The organising committee will be as 2022, that is R Snowden, D Cordle and K Plummer, the proposed date is 20/1/24, venue to be decided.

- 9. Please can clubs write trial's reports for the website and gazette, especially if photographs are available.
- 10. Please can results be published in the format defined in the Trials Conditions.
- 11. Arrangements were made to get perpetual trials wards back to R Snowden for engraving for presentation, it was decided to do this by class, A Class D Cordle, B Class R Snowden, C Class C Dopson, D Class P Nash. Trophies required to R Snowden before 1st January latest.
- 12. As there were five nominations for the Observers award, it was decided by a show of hands to make the 2023 award to Mr T and Mrs R Harvey. The award to be presented at the annual awards presentation or a local trial if more appropriate.
- 13. For 2024 the trials committee will be Paul Nash, Clive Dopson, Alan Foskew, Richard Snowden, Paul Fenn, Eddie Hood, Matthew Neale, Ian Johnston, Nick Ogden, James Newstead, Andrew Barrell and David Cordle. Roles for 2024 are to be agreed at the next call or meeting.

Away from the Forum the 2023 Novice Champion, Ralph Petts, is promoted to Intermediate and 2023 Intermediate Champion Jordan Bailey is promoted to Expert, both from 1/1/24, congratulations to both, other promotions may be made before 1/1/24.

Motocross Reserved Number Scheme

Renewals Only - available from Noon on Monday 4th Dec.

Now is the time to renew your number for 2024. If you want to ensure you keep the same number for the 2024 season, you must renew it by 31st January 2024 at the latest. **NO NUMBERS WILL BE HELD AFTER THIS DATE.**

Any numbers not renewed by 31st January will be made available on a first come, first served basis. If you have not renewed your number by this date, there is every possibility that you could lose it to another rider. There were about 700 numbers sold in each of the last 5 years so if you don't want to lose your number, renew it NOW.

You can renew your number online at www.easternacu.org

The cost of reserving your number for 2024 remains unchanged at $\mathfrak{L}5.50$ per season. This ensures that the chosen charities (East Anglian Air Ambulance, Essex Air Ambulance & ACU Benevolent Fund) receive just over $\mathfrak{L}5$ per transaction.

Numbers 1 –20 are kept for experts only. Number 1 is reserved for the Centre Champion.

Since its introduction this scheme has enabled the ACU Eastern, on behalf of riders, to make donations of more than £37,500 to the chosen charities.

The timing system will correctly calculate championship points and positions where riders compete in separate classes (expert / junior)
